GBV Prevention Priorities

- Center survivors' housing experiences and needs
 - Trauma-informed
 - Historically marginalized
 - "Hard to serve"
 - Intersectionality
- Create feedback loop
- Gather and analyze data

- Implement and enforce housing protections under Violence Against Women Act ("VAWA")
- Provide resources that target assistance to survivors
- Provide programs and services that create pathways to economic stability for families and individuals



Housing Protections of Survivors

- Violence Against Women Act
- Fair Housing Act
- State and local housing laws
 - Eviction defense
 - Early lease termination
 - Lock changes
 - Anti-nuisance ordinances



Violence Against Women Act

- VAWA enacted in 1994 as part of the Violent Crime Control and Law Enforcement Act of 1994.
- VAWA 2005 included a housing title for the first time.
- Congress reauthorized VAWA (and housing title) in 2013 and 2022.

Violence Against Women Act

- VAWA provides housing protections for survivors of domestic violence, sexual assault, dating violence, and stalking who are applying for or living in federally assisted housing.
- The law applies to a survivor regardless of sex, gender identity, sexual orientation, disability, or age.
- VAWA does not apply to market-rate rental housing (unless there is a voucher or other federal subsidy).

Snapshot of VAWA Housing Rights

Cannot be **denied** admission, be evicted, or have assistance terminated because of the violence committed against them

Right to strict confidentiality of information Can request that a perpetrator be removed from the lease or unit Must get a **notice of VAWA housing rights** and VAWA self-certification form

Can request an emergency transfer Survivors with Housing Choice Voucher can **move** with continued assistance Cannot **be retaliated against** by housing providers for asserting VAWA rights (2022)

Right to call 9-1-1 or emergency services without penalty (2022)

Other VAWA 2022 Requirements

CDBG Participating Jurisdictions must certify and report certain problematic laws and policies.

Provides VAWA enforcement authorities to HUD and DOJ.


Requires federal agencies to establish VAWA compliance review processes.

Amends the definition of "homeless" under the McKinney-Vento Homeless Assistance Act.

Establishes a Gender-based Violence Prevention Office and VAWA Director position at HUD.

Requires HUD to conduct a study assessing the housing needs of trafficking survivors experiencing homelessness or housing instability.

Provides HUD funding for VAWA training and technical assistance.

Recent VAWA Implementation



- 2022 Reauthorization
- Started VAWA 2022 trainings for **HUD** grantees
- Began study on housing needs of trafficking survivors
- Sent report to Congress re: HUD's VAWA implementation
- Held first interagency VAWA meeting
- Published 60-day notice for VAWA 2013 forms

- **VAWA** Tenant Protection Vouchers
- Created centralized VAWA website: www.hud.gov/vawa
- Published in Federal Register VAWA interim guidance for HUD grantees
- Issued VAWA enforcement notice (FHEO)
- Launched VAWA enforcement pilot project (FHEO)

- and FY23 VAWA training and technical assistance funding
- Summer Hold VAWA listening sessions
- Summer Training series for HUD field staff
- Publish updated VAWA forms
- Publish proposed VAWA 2022 rule
- Establish Office of GBV Prevention
