Dear Executive Director, and/or Housing Credit Agency Representative:

Pursuant to the terms and conditions outlined in Federal Register Notice FR-6201-N-01 <u>Federal Register: Administrative Guidelines: Subsidy Layering Review for Project-Based</u> <u>Vouchers</u>, and as set forth in the Memorandum of Understanding (MOU) executed between participating Housing Credit Agencies (HCAs) and the United States Department of Housing and Urban Development (HUD), HCAs are required to notify the Housing Voucher Financial Management Division (FMD) of Subsidy Layering Reviews (SLRs) approved by the HCA on HUD's behalf.

In an effort to streamline the SLR documentation process this letter clarifies the reporting protocol for the required notification for all HCAs in a uniform manner. Notifications of HCV approval must contain the following documentation:

- Copy of the Signed HCA Certification
- The HCA's Internal Recommendation and Sign-off
- The Developer's Disclosure of Sources & Uses of Funds
- The Development's Operating Pro Forma (Cash Flow)
- Copy of the PBV Commitment / Award Letter
- HUD Form 2880, and
- Appendix A: Rent Information and Project Summary (Enclosed)

Notifications of SLR approval must emailed to the FMD mailbox at <u>PIH.Financial.Management.Division@hud.gov</u>, no later than 30 days from the date of authorization.
