

## State of Oregon – Eviction Help

**Oregon and Multnomah County** have extended the moratorium: Oregon extended the June 30 eviction moratorium for 60 days, which now ends August 31. Multnomah County's eviction moratorium was extended through September 30. But renters need to be in the process of accessing Rental Assistance.
