SMALL BUSINESSES DELIVER GOODS AND SERVICES TO HUD

The U.S. Department of Housing and Urban Development (HUD), Office of Small and Disadvantaged Business Utilization (OSDBU), is pleased to present this inaugural annual report covering Fiscal Year 2017. The report highlights OSDBU's most notable achievements over the year.

OSDBU: Overview and Mission

Established by Congress in 1965, the U.S. Department of Housing and Urban Development (HUD) is the cabinet-level federal agency responsible for national policy and programs that address America's housing needs, improve and develop the Nation's communities and enforce fair housing laws. To support its programs and operations, HUD spends over \$1 billion annually on supplies and services. HUD is assisted in carrying out its responsibilities by a variety of independent contractors and vendors.

It is the policy of the Government to provide maximum practicable opportunities in its acquisitions to small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business and women-owned small business concerns (FAR Part 19.1). HUD's Office of Small and Disadvantaged Business Utilization (OSDBU) is responsible for ensuring that small businesses are treated fairly and that they have an opportunity to compete and be selected for a fair amount of HUD's prime contracting and subcontracting opportunities.

In 1978 Congress passed P.L. 95-507 which required every federal contracting agency to create an office of small and disadvantaged business utilization to develop, implement, and manage small business utilization programs, policies and procedures. Reporting directly to the head of the agency, HUD's Office of Small and Disadvantaged Business Utilization was established in 1979 pursuant to the provisions of Section 15(k) of the Small Business Act as amended (Sec. 221, P.L. 95-507).

The Department is committed to providing universal access to its procurement dollars for all types of businesses both small and large. A significant amount of HUD's contract dollars is awarded to small businesses which recognizes that small businesses are of vital importance to job growth and the economic strength of the country.

FY 2017 HUD SMALL BUSINESS ACHIEVEMENTS


Fiscal Year 2017 has been successful due in large part to the collaborative efforts of the Office of Small and Disadvantaged Business Utilization, the Office of the Chief Procurement Officer, and HUD Program offices. Accomplishments from FY 2017 include:


- Small business prime contract awards amounted to approximately 49% of all awards, exceeding the agency goal of 39%.
- Met statutory socioeconomic goals for Small Disadvantaged Businesses, Service-Disabled Veteran-Owned Small Businesses, and Women-Owned Small Businesses.
- Achieved Historically Underutilized Business Zone rate of 2.94%, just short of the agency's goal of 3%, the best result in eight years.
- Exceeded prime subcontracting goal in four of the five categories; Small Business, Women Owned Small Business, Small Disadvantaged Business and Service Disabled Veteran Owned Small Business.
- Received high grades from the Small Business Administration in administration of small business programs, earning an A+ two years in a row for fiscal years 2016 and 2017.


For FY 2017, resident property management services accounted for over 20% of HUD's total dollars awarded (531311).

What HUD buys in Headquarters

HUD's contracting needs may vary significantly from headquarters to its field offices. At headquarters, for example, contracts and purchases primarily support headquarters programs. They include professional services such as research studies, business process re-engineering, technical assistance to HUD funding recipients and logistical support services for maintenance and supplies.

What HUD buys in the Field

The majority of HUD's field contracts and purchases support the field program operations of the Department's Office of Housing. Under its Single Family and Multifamily Housing programs, HUD manages, markets, and sells single and multifamily real estate properties.

Contracted services include property management, property marketing, sales closings, routine inspections and appraisals.

For the mortgage insurance programs, contracted services may include mortgage credit analysis, mortgage insurance endorsement processing, title service and underwriting analysis.

Purchases of general supplies and services to support HUD's field offices normally do not provide any significant contracting opportunities. Most of these purchases are made with local vendors using simplified acquisition procedures.
