Introduction

Overview

The United States Department of Housing and Urban Development (HUD) provides funding to state and local governments, nonprofit organizations, and other housing partners to help individuals and families find safe, stable, and affordable housing. HUD relies on local public housing agencies, private landlords, and local governments to administer the programs following HUD's guidelines.

We encourage you to use the information in this guide to find out about housing and related assistance you may be able to receive. Funding is limited and not everyone can be assisted. Some programs have waiting lists or other special criteria. The level of assistance can depend on your income level or other eligibility criteria such as age, veteran's status, disability, and other specific criteria; assistance also depends on the availability of funding in the area.

How To Use This Guide

This guide is designed to help you get in contact with our partners and to give you more information about the programs that HUD and other organizations have available to assist you. In most cases, HUD funds these programs but does not directly administer them. HUD does not accept applications for assistance or screen applicants or determine program eligibility. Generally, these programs are administered by other entities and can involve a multitude of programs such as rental assistance, homeownership, homelessness, housing counseling, and fair housing.

Fair Housing and Equal Opportunity

The Fair Housing Act protects people from discrimination when they are renting, buying, or securing financing for any housing. The prohibitions outlined in the Fair Housing Act specifically cover discrimination based on race, color, national origin, religion, sex, disability and the presence of children.

In addition to the Fair Housing protections, The Maine Human Rights Act has additional discrimination caveats but only for the State of Maine. The prohibitions of the Maine Human Rights Act are it is illegal to discriminate against any person because of race, color, religion, national origin, ancestry, sex, sexual orientation or gender identity, disability, familial status, receipt of a permanent protection order or receipt of public assistance.

Providers should help individuals regardless of what language they speak. It is illegal to discriminate against someone based on race, color, national origin, religion, sex (including gender identity or sexual orientation), familial status, or disability when they are trying to rent or buy a home, get a mortgage, seek housing assistance, or engage in other housing-related activities. What housing is covered?

The Fair Housing Act covers most housing. In some circumstances, the Act exempts owner-occupied buildings with no more than four units, single-family housing sold or rented without the use of a broker and housing operated by organizations and private clubs that limit occupancy to members.

If I think my rights have been violated, where do I file a discrimination complaint?

You may also complete the Housing Discrimination complaint form included in this book as Attachment A and return it to the office listed above either by mail, email, or fax. The HUD Form 903 Online Complaint ([HUD Form 903 Complaint](#)) is also available for you to download and submit. You have one year after an alleged violation to file a complaint with HUD, but you should file it as soon as possible.

What to include in your complaint to HUD:

- Your name and address along with the date the discrimination occurred
- The name and address of the person your complaint is against (the respondent)
- The address or other identification to the housing involved
- A short description to the alleged violation (the event that caused you to believe your rights were violated)
- The date(s) of the alleged violation

Resources for Finding a Home

Housing Counseling

What is Housing Counseling?

HUD's Housing Counseling Program assists individuals and families with searching, obtaining, and maintaining a home, whether it is renting or owning.

HUD certified housing counselors are experienced, trained professionals with the answers you need for your housing decisions. Your housing counselor will work with you one-on-one to provide guidance to make the right choices based on your situation and your needs. Housing counseling agencies offer one-on-one counseling, classes, workshops, resources, and referrals. These services are provided for free or at a low-cost to you.

Who is Housing Counseling for?

Housing counselors can help with a wide range of issues, whatever your housing need may be. Housing counseling agencies can help you find an apartment to rent, help you with the homebuying process, or help you find options if you are currently at risk of foreclosure.

How Can I Find a Housing Counseling Agency?

To find a HUD-approved housing counseling agency in your local area, call (800) 569-4287 or (202-708-1455 TTY), or use the online search at www.hud.gov/housingcounseling. HUD-certified housing counselors are trained to assess an individual's financial situation, explain the housing options available, and help with accessing the resources and programs available. As a courtesy, we have attached a list of housing counseling agencies in the State of Maine as Attachment F at the end of this guide.

Rental Assistance

The HUD programs listed below provide rental assistance and low-rent housing to low- and moderate-income individuals and families. To access these programs, you must meet certain program criteria, and you must be a U.S. citizen/national or have an eligible immigration status. For some HUD programs, such as public housing and Section 8, households with U.S. citizens and people with other immigration statuses (called "mixed-status families") may also be eligible for assistance. We have included the income limits for HUD programs as Attachment B to this guide.

HUD funds several programs which help public agencies and private property managers provide affordable rental units to lower-income households.

HUD does not provide or manage housing units directly. HUD also does not manage or maintain waiting lists for any of the properties.

There are three major HUD funded programs that provide housing assistance, which will be explained further in the next few pages of this guide:

- Public Housing
- Housing Choice Vouchers (Section 8)

- Privately Owned Subsidized Housing

Key Questions to ask: When calling a housing authority or property manager, some of the questions you might ask are:

- What are the income requirements for this particular program or specific unit?
- Are you accepting applications?
- Do you have any preferences? There may be preferences for disabled, homeless, victims of domestic violence or city/town residents, etc.
- For housing authorities: What programs do you have (i.e., a housing authority may only have a voucher program, or may have some other form of assistance available)
- For private property managers: Do you have other properties where there may be vacancies? Do you have any preferences?
- Is the rent based on my income or is it set at a reduced or lower rate?

Rental Assistance – Public Housing

What is Public Housing?

Public housing was established to provide decent and safe rental housing for eligible low-income families, the elderly, and persons with disabilities. Public housing comes in all sizes and types, from scattered single-family houses to high-rise apartments for elderly families.

Who is eligible?

Public housing is limited to low-income families and individuals. A Public Housing Authority (PHA) determines your eligibility based on: 1) annual gross income; 2) whether you qualify as elderly, a person with a disability or as a family; and 3) U.S. citizenship or eligible immigration status. If you are eligible, the PHA will check your references and background to make sure you and your family will be good tenants. PHAs may deny admission to any applicant whose habits and practices may be expected to have a detrimental effect on other tenants or on the project's environment.

PHAs use income limits developed by HUD. Income limits vary from area to area so you may be eligible at one PHA but not at another. The PHA serving your community can provide you with the income levels for your area and family size, or you can also find the income limits [here](#). We have also included the income limits for various counties and localities in the State of Maine as Attachment B to this guide.

How do I apply?

Because HUD does not manage properties directly, we do not process applications. To apply for public housing, contact your local PHA. We have included the listing of Maine Housing Authorities ([PHA Contact Report by State and City \(hud.gov\)](#)) as Attachment C to this guide. Note: not all Maine Housing Authorities operate a public housing program, some only operate a Section 8 Voucher Program, which is indicated on the listing in the appendix.

Will I need to produce any documentation?

Yes, the PHA will request whatever documentation is needed (e.g., verification of income, birth certificates, tax returns, identification) to verify the information given on your application. The PHA will

also rely on verification from your employer, etc. You will be asked to sign a form to authorize release of pertinent information to the PHA.

When will I be notified?

A PHA must provide written notification regarding its determination of your eligibility for Public Housing. If the PHA determines that you are eligible, your name will be put on a waiting list, unless the PHA is able to assist you immediately. Once your name reaches the top of the waiting list, the PHA will contact you. If it is determined that you are ineligible, the PHA must say why and, if you wish, you can request an informal hearing.

Will I have to sign a lease?

If you are offered a house or apartment and accept it, you will be required to sign a lease with the PHA. You may have to give the PHA a security deposit. You and the PHA representative should go over the lease together. This will give you a better understanding of your responsibilities as a tenant and the PHA's responsibilities as a landlord. You may also have to sign other certifications and paperwork required by HUD as well.

Are there any selection preferences?

Giving preference to specific groups of families enables a PHA to direct their limited housing resources to the families with the greatest housing needs. Examples of a local preference include one for seniors, disability, homelessness, or veteran status. Since the demand for housing assistance often exceeds the limited resources available to the local PHAs, long waiting periods are common. In fact, a PHA may close its waiting list when there are more families on the list than can be assisted in the near future. Ask the local PHA if they have any preferences.

Rental Assistance – Housing Choice Vouchers

What are Housing Choice Vouchers?

A Housing Choice Voucher (HCV) allows an individual or family to choose any housing that meets the requirements of the program and is not limited to units located in subsidized housing building. Housing choice vouchers are administered locally by the Public Housing Authority (PHA). The PHAs receive federal funds from HUD to administer the voucher program.

A family that is issued a voucher is responsible for finding a suitable housing unit of the family's choice where the owner agrees to rent under the program. This unit may include the family's present residence. Rental units must meet minimum housing standards of health and safety, as determined by the PHA.

A housing subsidy is paid to the landlord directly by the PHA on behalf of the participating family. The family then pays the difference between the actual rent charged by the landlord and the amount subsidized by the program. Under certain circumstances, if authorized by the PHA, a family may use its voucher to purchase a modest home.

Am I eligible?

Eligibility for a housing voucher is determined by the PHA based on the total annual gross income and family size and is limited to U.S. citizens and specified categories of non-citizens who have eligible

immigration status. In general, the family's income may not exceed 50% of the median income for the county or metropolitan area in which the family chooses to live. Median income levels are published by HUD and vary by location, we have included these income limits in Attachment B to this guide or you may contact the PHA serving your community who can provide you with the income limits for your area and family size.

During the application process, the PHA will collect information on family income, assets, and family composition. The PHA will verify this information with other local agencies, your employer and bank. This information will be used to determine program eligibility and the amount of the housing assistance payment.

If the PHA determines that your family is eligible, they will put your name on a waiting list, unless they are able to assist you immediately. Once your name is reached on the waiting list, the PHA will contact you and issue you a housing voucher.

How do I apply?

You can apply for a Housing Choice Voucher through the PHA. You can apply to as many housing authorities as you wish but it is recommended that you apply to at least one PHA on the [Centralized Waiting List](#). This is a group of 20 housing authorities in Maine that share one list, so that by applying to any one of them, you are in effect applying to all of them. An application and information about the Centralized Waiting List can be found online to apply or check your status on the Waiting List ([Maine Section 8 HCV Centralized Wait List Application](#)).

Local preferences and waiting list – what are they and how do they affect me?

Each PHA has the discretion to establish local preferences to reflect the housing needs and priorities of its particular community. Giving preference to specific groups of families enables a PHA to direct their limited housing resources to the families with the greatest housing needs. Since the demand for housing assistance often exceeds the limited resources available to HUD and the local PHAs, long waiting periods are common. In fact, a PHA may close its waiting list when there are more families on the list than can be assisted in the near future. Ask the PHA if they have any preferences.

Rental Assistance – Multifamily Housing

What is Multifamily Housing?

This refers to privately-owned housing complexes that can be subsidized by HUD, or the rents are restricted and kept low because the owner used special financing, or the building is a bunch of apartments with “regular” or “market rate” rents. The landlord is the private property owner.

How do I find a Multifamily rental housing listing?

Please visit [ME Multifamily Housing List](#) or Attachment D for a listing of multifamily housing assisted by HUD located in the state of Maine. These apartments are separated by the county and the city in which they are located. We have also included information on which populations each of these apartment buildings serve:

- Elderly/Disabled – Apartments for persons or families where at least one person is 62 years old or older. In some cases, they are also available for handicapped and/or disabled persons

- Family and Elderly – Some apartments are reserved exclusively for elderly households as defined above
- Family – Apartments for families with no general restrictions on the type of household that can be admitted
- Congregate – Apartments for supervised group living. If you believe you qualify, speak with the project manager about any special restrictions
- Assisted Living – Elderly properties with some assisted living units*

If no one in your family is elderly, handicapped or disabled, apply at Family or Elderly/Family properties

Who do I contact to apply for a Multifamily rental housing listing?

Each multifamily property listing in our guide has a phone number to contact each individual listing to ask about vacancies, eligibility, rents, and application procedures. Each property has its own system for accepting applications for the rental units they administer. In some cases, there are waiting lists and sometimes those waiting lists can be very long.

Homeownership Programs

Thinking about buying a home?

FHA loans have been helping people become homeowners since 1934. The Federal Housing Administration (FHA) – which is part of HUD – insures the loan, so your lender can offer you a better deal such a low-down payments, low closing costs, or easy credit qualifying. Your state housing authority or finance authority may also offer homeownership programs. Please see www.mainehousing.org for more information.

Buying your first home?

FHA might be just what you need. Your down payment can be as low as 3.5% of the purchase price. Available on 1–4-unit properties.

Housing Counselors can help

Want advice on buying a home, renting, default, foreclosure avoidance, credit issues or reverse mortgages? HUD approved housing counseling agencies throughout the country provide free or low-cost advice.

How about manufactured housing and mobile homes?

Yes, FHA has financing for mobile homes and factory-built housing. We have two loan products – one for those who own the land that the home is on and another for mobile homes that are – or will be – located in mobile home parks. Ask an FHA lender to tell you more about FHA loan products.

How do I apply?

You can finance a home with a loan from a bank, a savings and loan, a credit union, a private mortgage company or various state government lenders. Shopping for a loan is like shopping for any other large purchase. You can save money if you take some time to look around for the best prices. Different lenders can offer quite different interest rates and loan fees; a lower interest rate can make a big difference in how much home you can afford. Talk with several lenders before you decide. Most lenders need 3-6 weeks for the whole loan approval process.

HUD Homes for Sale

What is a HUD home?

A HUD home is a 1-4-unit residential property acquired by HUD because of a foreclosure action on an FHA-insured mortgage. HUD becomes the property owner and offers it for sale to recover the loss of the foreclosure claim.

How do I find a HUD Home for Sale?

[HUD Homestore](#) is the listing site for HUD real estate owned (REO) single-family properties. This site provides the public, brokers, potential owner-occupants, state and local governments and nonprofit organizations a centralized location to search the inventory of HUD properties for sale. In addition, registered real estate brokers and other organizations can place bids on behalf of their clients to purchase a HUD property. HUD Homestore also includes many informative user-friendly features providing advice and guidance for consumers on the home buying process.

Resources for Staying in Your Home

Foreclosure Prevention

If you are having trouble making your mortgage payments, there may be options available based on your financial situation and the type of mortgage insurance you have. Help is available, but you need to take

the first step. If you ignore the problem, you may lose your home to foreclosure, possibly affecting your ability to qualify for credit or to rent another home.

What Should I Do If I Am Facing Foreclosure?

Your first step if you are facing a possible foreclosure is to contact your lender right away. If you are not able to work something directly out with your lender to avoid foreclosure, or if you would like additional assistance before talking to your lender, a HUD-approved housing counseling agency can help you understand your options. A HUD-approved housing counseling agency can also help you navigate other aspects of your mortgage. What if I Have an FHA Insured Mortgage?

Other Programs to Help with Home Costs

Want to make your home more energy efficient?

You can include the costs of energy improvements into an FHA Energy-Efficient Mortgage. [HUD FHA Insured Energy Efficient Mortgages | HUD.gov / U.S. Department of Housing and Urban Development \(HUD\)](#)

Want to purchase a home that needs rehabilitation or get financing for rehabilitation on a home you own?

Section 203(k) insurance enables homebuyers and homeowners to finance both the purchase (or refinancing) of a house and the cost of its rehabilitation through a single mortgage or to finance the rehabilitation of their existing home. Applications are made through an [approved FHA lender](#).

Community Action Agencies

Community Action Agencies administer fuel assistance programs and provide help with electric and gas bills including the administration of the Home Energy Assistance Program (HEAP), insulation/weatherization and furnace repairs. Many CAA offices also help with a wide variety of services including job training, day care and housing information. Resources for Specific Populations

Many of HUD and its partners programs are targeted to reach populations that meet a specific criterion, e.g., elderly or disabled persons, people experiencing homelessness, or veterans. The next few pages highlight some of the resources available to you if any of these criteria apply to you.

Resources for Veterans

Does HUD have any housing programs specifically for homeless Veterans?

The HUD-Veterans Affairs Supportive Housing (HUD-VASH) program combines Housing Choice Voucher (HCV) rental assistance for homeless veterans with case management and clinical services provided by the Department of Veterans Affairs (VA). The VA provides services for participating veterans at VA medical centers (VAMCs) and community-based outreach clinics. Eligibility for HUD-VASH is determined by the VAMC staff, but follows the following general guidelines:

1. Homeless or at risk of homelessness
2. Assessed and evaluated through outreach and intake with a HOMES Assessment interview
3. Meet income guidelines established by the Department of Veterans Affairs

Resources for Senior Citizens

Home Equity Conversion Mortgages – Reverse Mortgages

Reverse mortgages are a way for seniors who have equity in their homes to supplement their income or to aid in the purchase of a new primary residence. The only reverse mortgage insured by the U.S. Federal Government is called a Home Equity Conversion Mortgage, or HECM, and is only available through an [FHA approved lender](#).

To qualify for a HECM or reverse mortgage, you must be a homeowner aged 62 or older and have paid off or paid down a considerable amount of your mortgage, occupy the property as your principle residence, not be delinquent on any federal debt, have financial resources to continue to make timely payments and participate in a consumer information session given by a HUD- approved HECM counselor. The HECM works by enabling you to withdraw a portion of your home's equity. The HECM can be used to either supplement income or to purchase a primary residence. To purchase a primary residence, you must be able to use cash on hand to pay the difference between the HECM proceeds and the sales price plus closing costs for the property you are purchasing.

There are many factors to consider before deciding whether a HECM is right for you. To aid in the decision process, you must meet with a HECM counselor to discuss program eligibility requirements, financial implications, and alternatives to obtaining a HECM and repaying the loan. Counselors will also discuss provisions for the mortgage becoming due and payable. Upon completion of HECM counseling, you should be able to make an independent, informed decision of whether this product will meet your specific needs.

Section 202 Supportive Housing for the Elderly Program

HUD's Section 202 program helps expand the supply of affordable housing with supportive services for the elderly. It provides very low-income elderly with options that allow them to live independently but in an environment that provides support activities such as cleaning, cooking, transportation, etc. Occupancy in Section 202 housing is open to any very low-income household comprised of at least one person who is at least 62 years old at the time of initial occupancy. For a list of housing, see Attachment D.

Public Housing

Some Public Housing Authorities have designated housing for the elderly or may have certain preferences for the elderly in their public housing or housing choice voucher programs. To see a list of housing authorities to contact for their elderly housing options, see [Attachment C](#).

Other federal programs for seniors

U.S. Department of Agriculture Rural Development has a number of programs available for residents of rural communities including subsidized multifamily housing developments, home repair loans, grants and more. A wide variety of organizations including state government, local government and non-profit organizations assist persons at risk for homelessness or currently experiencing homelessness. The type of assistance varies based on your unique circumstance. Assistance can include emergency sheltering for individuals or families, food, job training, and assistance specifically for homeless veterans.

HUD Programs

Continuum of Care (CoC) – The Continuum of Care program provides non-profit organizations, state and local governments resources to quickly rehouse homeless individuals and families while minimizing the trauma and dislocation caused by homelessness. This is done in the state of Maine through a state-wide Continuum of Care. The Maine Continuum of Care covers the entire State of Maine and supports projects throughout the region. The MCOC's mission is to plan and coordinate an inclusive system that helps Maine people avoid or exit quickly from homelessness. Resources for those Experiencing Domestic Violence

Violence Against Women Act (VAWA)

The Violence Against Women Act (VAWA) provides protections for victims of domestic violence, dating violence, sexual assault, or stalking. VAWA protections are not only available to women but are available equally to all individuals regardless of sex, gender identity, or sexual orientation.

HUD housing programs may not deny or terminate applicant/tenant assistance or tenancy on the basis or as a direct result of the applicant or tenant currently or having been a victim of domestic violence, dating violence, sexual assault, or stalking if the applicant or tenant otherwise qualifies for admission, assistance, participation, or occupancy.

Eligible for VAWA Protections:

- Applicants and tenants of HUD housing programs who are victims of domestic violence, sexual assault, or stalking
- Not limited to women and available to all, without regard to sex, gender identity, or sexual orientation

HUD has a long history of working to ensure lead-safe housing, which fits into the broader federal response to address lead hazards found in paint, dust and soil, and other sources like water and consumer goods. Lead Safe Housing

Lead is a highly toxic metal that may cause a range of health problems, especially in young children. When lead is absorbed into the body, it can cause damage to the brain and other vital organs, like the kidneys, nerves, and blood. Both inside and outside the home, deteriorated lead-paint mixed with household dust and soil becomes tracked in.

On January 13, 2017, HUD published an amendment to the Lead Safe Housing Rule on responding promptly to cases of children under age 6 living in certain categories of HUD-assisted housing who have elevated blood lead levels. When a child under age 6 resides in HUD-assisted housing and has an elevated blood level, the housing provider will have to test the home and other potential sources of the child's lead exposure within 15 days, and ensure that hazards from lead-based paint, dust or soil are controlled within 30 days. The housing provider must also report the case to HUD so the Department can ensure that follow-up is completed on time.
